Memorandum of Understanding (MOU)

Between

Gangarampur College

With

Kumarganj College

P.O. + P.S. – Kumarganj; Dakshin Dinajpur, PIN-733141

Gangarampur College and Kumarganj College enter into this agreement to facilitate the Institutional visit and the development of and similar other issues which can be reached between the two institutions.

For the purposes of this agreement:

1st:- The institution shall mean Gangarampur College

and

2nd:- Institution shall mean Kumarganj College.

"1st" institute will provide teachers from different department including exchange of:

(i) Exchange teachers for classes, assignments, presentations, practicum for better knowledge sharing and innovation including value aided courses.

- (ii) Promote cultural and intellectual enrichment opportunities for the students and faculties of both the institutions.
- (iii) Collaboration in research or training programmes sponsored by UGC, NAAC, NCTE and other funding agencies and invites each other faculty for special lecture for participation and exchange knowledge etc.

"2nd" institute will take the responsibility of guiding trainees through providing manpower and audio-visual setup including:

- (i) Exchange of Information on research and educational programmes and involvement in research projects with collaboration.
- (ii) Exchange of teachers for classes, assignments, presentations, practicum for better knowledge sharing and innovation and exposure,
- (iii) Exchange of faculty members for using library and museums, archives for constructive knowledge sharing and enlightenment.


1. Mutual agreement for free of cost, exchange of knowledge and sharing information. Decision about schedule exchange programme will be taken by Principal of both the institutions.
2. Method, Procedures, Pedagogy and detailed programmes regarding exchange programme will be decided by the Principals and respective faculty members of both the institutes.
3. Exchange programme will depend upon need of students with respect to curriculum and co-curricular activities.
4. Both the institution agreed to collecting publishes articles, research papers, book, and journals.
5. Both the institutions agreed to collecting arrange/organize guest lectures, extension lectures, orientations programmes, seminars, workshops etc. to encourage the research in both the institution.
6. This MOU is valid at least for a period of five (05) years. Maintaining good relations it will be extended further for mutual benefits of institutions.
7. There is no fund flow from one institution to another.
8. Both the institutions will link themselves for faculty exchange, academic and outreach activities jointly.

Other Provisions

- A. Departments of Education, History, Bengali, English, Sanskrit, Philosophy, Economics, Geography, Political Science of both colleges will be engaged to exchange their faculties for teaching Graduate students under this exchange programme

- B. This type of exchange may be implemented in the field of cultural programmes and sports competitions.
- C. Teachers of one party may visit and used departmental library as well as central library of the other party.
- D. Teachers may use the resources of reverse college during the exchange and extension activities.
- E. With due prior permission of the concerned authorities' classes may be shared to each other amongst the faculties.
- F. Faculty exchange for special lectures, seminar classes and other programmes will be made at the departmental level with due consult of specific faculty and the department.
- G. Both parties assume that this agreement does not go against the rules and regulations of the Government of WB and also UGB.

The general purpose of this agreement is to establish specific educational relations and cooperation between the two participating Institutions in order to promote academic linkages and to enrich the skill development in teaching-learning techniques and human resource management.

It will remain valid till any of the parties chooses to withdraw from the linkage.

Any notice or other communication under this agreement shall be given in writing and delivered by hand, sent by post, facsimiled transmission or e-mail.

This agreement constitutes the agreement in principle to proceed and workout more detailed modalities to operationalize the same between the parties. No amendments consent or waiver of terms of this agreement shall bind either party unless in writing and signed by both parties.

The MOU will be valid for 5 years.
